

## PREAMBLE

Pursuant to **Act of Claim Resuming Right to Sovereignty of Bosnia proper by Unjustly Dispossessed Sovereign de Jure**, Decretum 1. of 21 July 2010, and due to clear untenability of the present situation of involuntary dispossession of a sovereign as based on international law, and, likewise, due to unclear rule of an international contract and the resulting evident destitution for most people in our society, which is all peculiar for Europe's traditional nations, I hereby resume the sovereignty of Bosnia proper, and *Ultra Vires* declare this:

# Act of Constituting Kingdom of Bosnia

## REMINDING THE PEACE IMPLEMENTATION COUNCIL OF SOVEREIGNTY USURPATIONS:

- PURSUANT TO INTERNATIONAL LAW AND CUSTOMS, PREVIOUS POSSESSIONS OF SOVEREIGNTY OF BOSNIA PROPER BY INDIVIDUAL FOREIGN SOVEREIGNS MAKE AN UNBROKEN SERIES OF USURPATIONS OF THE SOVEREIGNTY OF BOSNIA PROPER TO HER MORALLY AND LEGALLY/FACTUALLY UNJUSTLY DISPOSSESSED SOVEREIGN, WHERE BOSNIA PROPER IS *TERRA NULLIUS IN DE JURE*, AND
- BOSNIA PROPER HAS BEEN AVERTED FROM HAVING HER OWN ENTITLED DE JURE SOVEREIGN (A MONARCH, A PRETEND, A PRESIDENT, A PREMIER) SINCE FORCED DISPOSSESSION VIA REGICIDE OF 1463. & 1535., FORMAL-LEGALLY CONTINUOUSLY SINCE THE ESTABLISHING OF THE FIRST OCCUPYING ADMINISTRATION OF 1527 UNTIL JULY OF THIS YEAR, WHERE THE RIGHT TO SOVEREIGNTY IS NOT SUBJECT TO STATUTE OF LIMITATIONS FOR AS LONG AS THE RIGHT IS BEING USURPED, AND
- THERE IS, OBJECTIVELY AND INCESSANTLY, USURPATION OF SOVEREIGNTY TO UNJUSTLY DISPOSSESSED SOVEREIGN OF BOSNIA PROPER IN FORCE PRESENTLY AS WELL, BY THE SOVEREIGNS OF THE COUNCIL MEMBER-NATIONS; AND

## CONSIDERING WELL-KNOWN EVIDENCE OF INADEQUACY OF THE DE FACTO ORDER:

- TOTAL ECONOMIC WRECK AND BACKWARDNESS OF OUR SOCIETY, AND TO THAT RELATED DRAMATIC UNEMPLOYMENT RATE AND FALTERING AMONGST ALL GENERATIONS, RESULTING IN HOPELESSNESS OF SIGNIFICANT PROPORTIONS,
- HIGH RATE OF VIOLATION AND IMPERIL OF HUMAN RIGHTS AND FREEDOMS, WITH UBIQUITOUS CRIME, ALL FULLY JEOPARDIZING ALL PEOPLE AND ALL PROPERTY,
- UNSTABLE STATE OF NATIONAL SECURITY, WITH TERRORIST ACTS TAKING PLACE,
- INADEQUATE LEGISLATURE AND RAMBLING JUDICIARY,
- FREQUENT MEDIA EXPOSURE OF LURID SCANDALS FROM WITHIN THE SYSTEM OF JUSTICE, AS WELL AS INAPT APPROACH AND SLUGGISHNESS ON PART OF THE JUSTICE SYSTEM TOWARDS THOUSANDS OF INDIVIDUALS WHO, CLEARLY SO, ARE INVOLVED IN WAR CRIMES BUT REMAIN OUTSIDE OF PROSECUTORIAL ACTIVITIES,
- PERVASIVE APPEARANCES OF POLITICAL IRRESPONSIBILITY, NON-STATUTORY BEHAVIOR, FRIVOLOUSNESS, FAVORITISM, AUTOCRACY, ARBITRARINESS, PRODIGALITY, CORRUPTION, AS WELL AS NUMEROUS SCANDALS WITHIN THE SYSTEM OF GOVERNMENT BUT ALSO ACROSS THE SOCIETY AT LARGE,
- THE FACT THAT, BY THE END OF THE SECOND DECADE OF A DRAMA LAUNCHED BY THE BALKAN WARS OF 1990-IES, THERE IS NOT EVEN A HINT IN THE DIRECTION OF A FUNDAMENTAL SOLUTION TO THE POLITICAL, ECONOMIC AND SOCIETY CRISES, WHILE THE DISAPPOINTMENT HAS GROWN GENERAL,

WHICH OVERALL BORDERS ON A STATE OF ANARCHY OR EXPECTED ANARCHY; AND

## GIVEN A WELL-KNOWN ATTITUDE OF THE PRESENT SOVEREIGNTY USURPER, WHERE:

- SOVEREIGNS OF COUNCIL MEMBER-NATIONS AS THE ONLY USURPER OF BOSNIA SOVEREIGNTY OVER THAT PERIOD OF TIME DISPLAY(ED) NEITHER POTENCY NOR WILLINGNESS NEEDED TO IMPROVE THE SITUATION, WHILE INSTEAD IMPEDING A LUSTRATION OF COMMUNIST CADRE THEY KEEP SUPERVISING TWO DECADES ON;

I DECIDE AS IN THE DISPOSITIVE PART,  
AND SO ESTABLISH, MAY GOD HELP US
